ORDER

WHEREAS in term of section 14(1) of the NCTE Act, 1993 Gurukul Bharti College of Education, Vill-Benla Brahmna, P.O Chandpur, Distt Bilaspur(HP) had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/ permission for starting B.ED course of one year duration with an annual intake of 100 (one hundred only) seats on 31.12.2007.

AND WHEREAS, the application was processed and the inspection of the institution u/s 14 was conducted on 29.06.2009. The matter was placed in its 144th meeting held from July 12-14, 2009 and committee decided that to issue Show Cause Notice. Accordingly, Show Cause Notice was issued to the institution on 22.07.2009 on certain grounds.

AND WHEREAS, The reply dated 24.7.2009 of the institution in response to show cause notice was considered by the NRC in its 147th meeting held on August 16-17, 2009 and NRC decided to refuse the recognition. Accordingly, refusal order was issued to the institution on 31.08.2009 on certain ground.

AND WHEREAS, The above said institution, thereafter preferred an appeal before the Council (NCTE, New Delhi) under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 05.01.2010 accepted the appeal and reversed the NRC's order dated 31.08.2009 with direction to NRC to issue letter of intent prior to recognition to the institution under clause 7(9) of NCTE Regulation 2007 within a period of 15 days. Accordingly, the letter under clause 7(9) was issued to the institution on 01.01.2010.

AND WHEREAS, the reply submitted by the institution w.r.t to letter of 7(9) issued by the NRC in its 160th meeting held from May 18-20, 2010 and NRC decided to refuse recognition to B.ED Course and return FDRs if submitted. Accordingly, refusal order was issued to the institution on 01.01.2010.

AND WHEREAS, the said institution had preferred an appeal before the Council (NCTE, New Delhi) under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 15.09.2010 accepted the appeal and reversed the NRC's order dated 01.06.2010 and the case was remanded to NRC with direction to NRC to allow a period of two months to comply with the requirement of appointing qualified staff through duly constituted selection committee and take appropriate decision thereafter.

AND WHEREAS, The appeal order dated 15.09.2010 was considered by the NRC in its 173rd meeting held from November 24-26, 2010 and NRC decided that in compliance of appeal order dated 15.09.2010, time of two months be given to the institution to comply with the requirement of appointing qualified staff as per the NCTE Norms, 2009. Accordingly, letter was issued to the institute on 16.12.2010.

AND WHEREAS, the reply dated 15.02.2011 submitted by the institute in response to the NRC's letter dated 16.12.2010 was considered by NRC in its 180th meeting held from March 23-26 & 31st March to 1st April, 2011 and the NRC decided to issue formal recognition order under clause 7(11) of the NCTE Regulation, 2007 with usual condition.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants the recognition to Gurukul Bharti College of Education, Vill-Benla Brahmna, P.O Chandpur, Distt Bilaspur(HP) for B.ED Course with an annual intake of 100 (one hundred Only) seats under clause 7(11) of NCTE Regulation 2007 from the academic session 2011-2012 subject to the following conditions:-

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the ii) NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining iii) body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10.12.2007

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure: -

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the recognition was granted by NRC to the said institution for B.Ed. Course vide order No. NRC / NCTE / F-7 / HP-256 / 180th Meeting / 2011 / 10944-10950 dated 18.07.2011 with an annual intake of 100 seats from the academic session 2011-12.
- AND WHEREAS, the institution Gurukul Bharti College of Education, Bilaspur 174001, Himachal Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
 - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
 - The Regional Committees shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint
- Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Northern Regional Committee, NCTE hereby grants recognition to Gurukul Bharti College of Education, Bilaspur - 174001, Himachal Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

- 7. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - (a) Sanctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
